Introduction

Cornwall Consolidated School has the need for updated policy that aligns to the practices in place in a majority of the categories.

Compared to the previous assessments and a previous administrator, the scores reflect higher with the same policy in place. I have met with the superintendent to work on an updated Regional policy. Specific language in our policy is needed to provide more clarification in showing that we align with federal requirements. In addition, we have opportunities for growth that are currently under revision due to changes in the required curriculum or best practices within the NSLP guidelines. Our triennial assessment was completed using the WellSAT tool. The Principal reviewed the policy portion, and further review and analysis were completed with the physical education teacher and school nurse. The School Climate Committee designates a portion of their meetings to wellness at this time, but we will look to have two Wellness-only focused committee meetings next school year to review the new policy and triennial assessment before its submission to the Board of Education.

Strong Policies and Aligned Practices

A majority of the federal requirements in this section are related to the management and procedures of our school lunch program. We strictly follow the guidelines of the NSLP with support from our RESC Food Service Director. The director works closely with our cafeteria manager to ensure that all federal requirements are being met, and to encourage the implementation of some of the recommendations.

The wellness committee has transitioned to be a part of the school climate committee to encompass wellness, climate, and culture together. This puts an emphasis on school community wellness being a part of our school climate focus. The physical education program requirements ensure that students have access to physical activity for the required minutes. Additionally, it ensures that staff is encouraged to provide access when it is not scheduled (breaks, walks outside, etc.). Most of these sections were aligned in our previous triennial assessment. One difference would be the addition of a breakfast program and implementing the change will be great to offer a daily breakfast program to all students.

- 3a. PE teacher, Principal, School Climate Committee
- 3b. Timeline: 2025-2026 school year 3c. Assessment: Student count
